CAMUS Productions Year Ended 31st December 2024 Report of the Trustees

The trustees are pleased to present the annual report, together with the financial statements for the charity for the year ended 31st December 2024.

Basis of the Accounts

The financial statements comply with the Charities Act 2011 and are for the 12-month period ending 31st December 2024. As the gross income for the period is below the threshold of £25,000, the trustees have opted to carry out an independent examination with an external source, even though there is no requirement to do so.

Objectives & Charity Statement

The objective of the Society is to educate the public in the dramatic and operatic arts, and to further the development of public appreciation, and taste in the said arts and in furtherance of this object but not otherwise the Society through its management committee shall have the following powers:

- To promote plays, drama, comedies, operas, operettas and other dramatic and operatic works of educative value.
- To purchase, acquire and obtain interests in the copyright, or the right to perform or show, any such dramatic or operatic works.
- To purchase or otherwise acquire plant &, machinery, furniture, fixtures & fittings, scenery and all other necessary effects.
- To raise funds and invite and receive contributions from any person or persons whatsoever by way of subscription, donation and otherwise, provided that the society shall not undertake any permanent trading activities in raising funds.
- To do all such other things as shall further the objects of the Society

Chairman's Report

Over the last year, CAMUS premiered the show The Wedding Singer in June 2024. Despite a good effort selling the show & saving on costs, we unfortunately made a loss totalling £827. The committee attribute this loss purely to the drop in ticket sales when compared to the show budgeted amount. For the next show, we look to invest in our digital marketing further to improve ticket sales.

Despite some planning conflicts, CAMUS held a number of fundraising events, resulting in our Funraising Fund to be in profit of £1,108. These included our annual Awards Night to celebrate members past and present, making a profit of £585, attending our first Pride event which made a respectable profit of £7, and our much loved "On the Box" Quiz night hosted by Tom Mercer which made a profit of £506.

Due to poor ticket sales, the carried forward Murder Mystery show was cancelled in February 2024. This resulted in Bad Debts totalling £867 arising from rehearsal venue costs. The committee have reviewed this and are looking at ways in which we can ensure this loss of income does not occur in future.

Finally, our general fund, which includes membership and general expenses, made an overall loss of £2,344. This is largely due to needing to update some general advertising material along with a large drop overall in membership; something the committee is looking into.
